ABOUT GRAMA

Grameena Abivruddi Mattu Adhyayana Kendra better known by its acronym GRAMA is a non-government organization (NGO) working in the development sector since its inception in 1989. GRAMA was registered under the Indian Trust Act on 12th July 1989 (No.29/89 dated 02.07.1989). GRAMA which means village in Kannada has focus on the development of rural women as well as structural alleviation of poverty in rural areas. GRAMA promotes the Self Help Group (SHG) concept to develop rural women through self-sustainable institutions of people.

GRAMA works in selected villages of Chitradurga and Tumkur districts in the state of Karnataka. However GRAMA is also exploring the possibilities of extending its activities in other parts of Karnataka in collaboration with organizations and Government departments working on similar development issues.

GRAMA is implementing various projects funded by different agencies. The projects are mainly on natural resource management. They are NABARD watershed project Sujala-2 RIDF (funded by NABARD based on the guide lines of World Bank funded Sujala-1) organic forming etc. Apart from these projects GRAMA continues to focus on institution building which is GRAMAs core competency including Informal schools.

Vision of GRAMA

Irrespective of caste creed sex religion and region a democratic society with a sustainable developmental environment where everyone particularly women participates and takes their own decision.

Mission of GRAMA

Organizing the rural poor with special emphasis on women for economic social and political empowerment through active participation to initiate a sustainable developmental process.

Approach:

- The conceptualization planning with all concerned stake holders
- Implementation of development programmes with people's consensus.
- Institution Building and networking
- Capacity Building at all the level on various need based topics
- ➤ Cooperation and participation towards a long-term objective of rendering the communities a self-reliant status.

Objectives:

The main aims and objectives of the organization are broadly grouped into long-term and short-term objectives. The long-term objectives represent the envisaged situation when all the short-term objectives have been achieved.

Long Term Objectives

- To enable the poor to change their life situation through empowering them to address the root causes of poverty.
- To enable women gain socio-economic and political equality through improving the socio-cultural and economic status of women.
- To improve the socio-economic position of the rural poor women with focus on the economically backward people through sustainable development processes and integrating them with the mainstream development policies programmes and institutions.
- To restore ecological balance with the active involvement of the poor particularly women without burdening them further.
- To create awareness among the people about their rights and responsibilities through education and cultural activities.
- To empower the poor so as to enable them to influence the policy-making processes in their favor.
- Develop literacy and numeracy.

Short Term Objectives

- To develop sustainable and self-managed autonomous organizational system as well as income generation programs by forming the rural poor women into self-help and management groups.
- To identify and develop through training and awareness potentials in the villages in the form of volunteers to enable the expansion and reach of the organization.
- To identify and develop through appropriate training (leadership and management skills) leaders among the women to carry on the work independently.
- To develop strong gender perspective and environmental awareness
- To provide knowledge on basic rights and responsibilities
- To initiate different development activities centered on the functional and self- managed credit groups to strengthen the process of empowerment.
- To enable the target group tap and mobilizes local resources including government programs for their own benefit.
- Formation of Associations/ Committees/Societies to develop and manage Natural Resources.
- To network with other NGOs in the project area and at wider levels for lobbying and influencing the policy processes in favor of the poor.

The specific focus of GRAMA in the above is the development of sustainable people's institutions with focus on women promoting people's organizations such as Federation and Farmers Associations which are self-sustained.

HIGHLIGHTS OF THE YEAR

GRAMA Resource and information Centers (GRICS) were encouraged to run the informal schools and identify the programmes that are people friendly and help the GRIC members to avail the facilities from the Line departments. They are being equipped to meet the nontraditional requirements like running informal schools exposing to social security schemes etc. while six centres are functioning in another five project locations organizing people and forming Community Based Organisations like Self Help Groups (SHGs) and Tank Users Groups (TUG) is continued. These groups will be made independent before the projects are completed.

Even though Watershed Development Department discontinued the services of NGOs of Sujala-2 (RIDF) funded by NABARD from 1st of April 2013 the project is continued till 31.03.2014 and field staff was continued in the project. This project successfully treated 4950 hectares and benefited 1406 people. The watershed projects funded by NABARD are in various stages of progress in Sanikere Gopanahalli and Billarthynala in Challakere taluk. Different activities were under taken under NABARD WDF supported program such as preparation of Bio-pesticides and liquid manure exposure visit to Ranegaosiddi with regards to study of the watershed concept and implementation strategy marked the highlights for the year. Similarly exhibitions on organic farming awareness camps construction of cattle sheds to the beneficiaries construction of vermi compost and enrichment of compost pits are the highlights of organic farming program.

An impressive numbers are seen in the area of facilitating Capacity building and Entrepreneurship Development programmes during the current year (Ref Annexure-8). GRAMA facilitated training of over one thousand ASHA workers under NRHM (National Rural Health Mission). Under watershed development and tank development programmes IGA trainings were under taken and exposure trips to other successfully completed watersheds were organized. The reporting year observed the distribution of cheques to 44 beneficiaries under IGA program supported by NABARD WDF. (Ref Annexures-7)

Capacity building and focusing on the pipeline projects and strengthening of Informal Schools marked brisk activity in GRAMA during 2012-2013

INSTITUTION BUILDING

Institution building as a prime mover of all activities further strengthened during the current phase. The empowerment of rural poor especially the women and motivating them to raise their voice against exploitation and meeting their pressing demands is essential to any development initiative. In this mission GRAMA used institution building as the platform to help the various groups in meeting their pressing needs and demands. Several projects supported by World Bank NABARD Government of Karnataka and others have recognized GRAMA especially in the area of social mobilization training and awareness programs. In the past GRAMA has promoted and is promoting SHG's Area Groups Watershed committees Common interest groups Tank Users Groups (TUGs) etc.

In this **reporting period** GRAMA has organized 250 SHG under its fold with a membership of 2573 and savings of Rs.12818569/- The details are given in the annexure-5.

GRAMA Resource and Information Centre (GRIC)

Working with the rural communities GRAMA realized that for small grassroot institutions to function on a sustainable basis they need to be affiliated to a resource and information center or institution located within their vicinity. The GRIC provides them opportunities for skill development micro finance services marketing linkages information about welfare schemes and service for improving employment opportunities. This center is the core link between the community and the available resources/information for sustainable livelihood enhancement. The center encourages people to take up income generation activities as an alternative source of income thereby reducing pressure on land. Noticeable development in the function of GRIC of Maradihally and Gubbi are sending of SHG members to RUDSETI District Industrial Development Department and vocational trainings in Chitradurga Zilla Panchayath for skill trainings in different fields.

Additionally GRAMA's sustainable livelihood programme (GSLP) is implemented through GRICs. This program aims at stabilization of household income of the rural poor thus ensuring food security and improved quality life for them. The program also aims at making the poor communities self reliant in addressing their livelihood needs and problems. The following information and services provided to the SHGs are indicative and the scope for extending is wide and could be need based.

During the next reporting period it is planned to bring the GSLP and GRICS in a structured mode in alignment with Micro Finance programme.

GRAMA SCHOOL

Education is the process of all round development of human beings. The development should bring about both qualitative and quantitative behavioral changes in individuals in desired direction. The development and changes occur gradually over a period of time. The outcome of these changes are in the form of acquisition of knowledge development of understanding about different phenomena related to life inculcation of good human values creation of interest and attitude and ability to perform certain skills. This enable individuals to think logically and rationally for leading a happy purposeful and socially productive life. The desired behavioral changes occur through both formal and non-formal schooling system. GRAMA would like add in its curriculum Abacus and spoken English to the students in the coming years to enhance the skills of the students in Mathematics and English.

SPJIMR one of the leading B-Schools in India is collaborating with GRAMA and sending its MBA students for Social project work which is part of their curriculum. During the academic year 2012-13 the MBA students who have come for Social project work to GRAMA visited the non-formal schools run by GRAMA. They had an interaction with GRAMA school teachers students of the schools and GRAMA staff with regards to the development of the schools and they came out with syllabus for the students in English and Mathematics. This helped GRAMA to improve the quality of the GRAMA school students in English and Mathematics.

MAIN FOCUS OF GRAMA SCHOOL

Education is basic to all kinds of developments social political economic and technological. No nation can progress unless its citizen is well educated. For this an effective education system is a must. Educational objectives have a pivotal role in the system. Educational objectives teaching learning process and evaluation are all interrelated and interdependent. Each validates the others. In today's changing world scenario education is viewed as a means of human resource development. Learning objectives are defined as action statements covering all possible abilities and competencies to be developed in children through teaching learning experiences. The learning objectives have been classified according to workable and practical models. The rural children lack access to either tuition centers or the personality development institutions at village level unlike the urban. The main focus of this program is to facilitate the rural children to develop in all the aspects and also create interest towards studies so that the rate of drop-outs among the rural children can be addressed.

Goals of Non formal school.

- Create interest in children to study and acquire knowledge
- Develop literacy and numeracy
- Develop the capability to act responsibly towards others
- Take initiative and work creatively

Advantages of GRAMA schools:

- Creativity among the students.
- Notable improvement in English and Mathematics
- Extracurricular activities.
- Improvement in General-Knowledge and current affairs of the students

NATURAL RESOURCES MANAGEMENT (NRM)

In the present context any development initiative sans NRM component is absurd. The environment pollution and deforestation has direct impact on rainfall. The rainfall in the drought prone areas especially in the central part of Karnataka which includes Chitradurga district has been scanty and irregular. The reason for this situation is deforestation unscientific usage of water wrong techniques adopted by the farmers for cultivation etc. The concept of watershed is developed to overcome these situations. Different type of structures have been constructed from the upper reach to lower reach in order to percolate the excess runoff water in the lands to increase the ground water table and allowing the excess water to drain from the fields without affecting the soil. In other words conservation of soil and water is the main idea behind in watershed development.

In this backdrop and keeping in view of the importance of food security GRAMA continued its effort to the development of watershed area in Chitradurga district with the support of NABARD Government of Karnataka and RIDF. The watershed activity aims at rejuvenation of environment in an integrated approach which includes afforestation dry land horticulture land treatment livestock and IG activities for landless. The GRICs established by GRAMA in the watershed areas with a commitment to ensure post project management.

Watershed Management

In watershed area so far 17509 Ha of area has been treated in different projects with an investment of about Rs.171902891/- till March 2013. The implementation of these projects involved all the stakeholders including landless small and marginal farmer's right from the planning stage. The details of area of land treated and the money invested for the treatment under different projects since its inception till March-2013 is given in the tables.

Owing the responsibility of the landless and marginal farmers IGA activities are being promoted in the watershed projects. It has been the practice of GRAMA since its inception to promote IGA activities to vulnerable sections in the society. In this reporting period under NABARD sponsored watershed projects 10 skilled trainings are conducted for landless and marginal farmers with an expenditure of Rs.581000 and also revolving fund is distributed to the beneficiaries under IGA in Billarthynala to the tune of Rs.319000 benefiting 53 beneficiaries.

Implementation of watershed activities is not only the criteria for the development but also imparting of awareness to the beneficiaries in the watershed before the implementation is started. In this background awareness programs about watershed developments activities have been organized. Among them are trainings on watershed concept exposures to successfully completed watersheds demonstrations for the improvement of land fertility by controlling soil erosion through construction of bunds waste weirs to drain excess water and water harvesting structures and also by adopting the modern scientific technology in agriculture for the sustainable income of the farmer. It provides financial support by releasing Rs. 605360/-359936/- & 389400/- in Sanikere Gopanahally & Billarty watersheds respectively. Under these programmes 485 834 & 706 peoples are benefited .

In this reporting period another watershed project IWMP (Integrated Watershed Management Project)-3rd Batch is launched in Chitradurga district. This project is funded by the Government of India. About 41 staffs are working for the project implementation. In this project about 27000 Ha of land will be treated in 3 years with an investment of about 26 crores.

Organic Farming

The intensive usage of artificial manures has made the land alkaline. In this condition land looses fertility gradually and the yield also decreases proportionately. To overcome the adverse effect of artificial manure organic farming has been promoted and efforts are put in action to make it popular among the farmers. GRAMA is one of the pioneer NGO in the implementation of watershed activities has successfully implemented organic farming project in Chowlur Challakere taluk. Organic farming project is being implemented by GRAMA in N.Gauripura in Challakere taluk in collaboration with Department of Agriculture. During the year 2012-2013 about Rs. 250000 has been spent for implementation of development activities under organic farming by implementing different activities under this programmes. Under this project 71 farmers are benefitted which covers an area of 100 ha.

Case Study-1

Dyamappa a beneficiary of NABARD WDF project has shown that usage of organic fertilizers and Bio pesticides would increase not only the yield but also improves the fertility of the land and controls the pests and diseases. Dyamappa a member of Gopanahally Jalanaya Abhivruddhi Samithi attended the trainings and exposures conducted in NABARD project and put his experience into action. He uses naturally available medicinal plants such as neem agave lantana etc and parts of the plants cow dung and cow urine for the preparation of the organic fertilizer and bio-pesticides.

Dyamappa used organic fertilizers in his 2 acres of land and got good yield of jowar inspite of erratic rain fall and other natural calamities. He opined that use of organic fertilizers reduces the cost of cultivation and maintains the fertility of the land and controls the erosion of soil. Dyamappa shares his experience with co farmers with regards to the usage of organic fertilizers and its benefits. The local farmers are demanding for organic fertilizers from Dyamappa.

Case Study-2

Kamalamma W/o Gopal a landless woman lives with his husband in Gopanahally Challakere taluk. She used to go to others fields for labour to earn her bread and butter. But this income was not sufficient for leading the life. Kamalamma joined Sri Sharada SHG and attended IGA training program and subsequent exposure conducted by GRAMA under NABARD project. She availed loan from revolving fund given by NABARD and purchased a milching buffalo. Kamalamma is selling 10 ltrs of milk a day and earning Rs. 200 a day. After meeting all the expenses incurring towards the maintenance of buffalo Kamalamma earns a net profit of Rs. 100 a day. Now Kamalamma is economically independent and she is proud of NABARD project. The successful story of Kamalamma is an example to others who are economically dependent.

Case Study-3

Traditional type of cooking which is still prevailing in country side of India destroys the health of the women. GRAMA promoted a modern smokeless stove under demonstration (clean kitchen) program of NABARD sponsored project. The program is aiming at giving smokeless stove to 30 beneficiaries worth of Rs. 40000/-. 30 families of Gopanahally village are happy that they are free from smoke which is hazardous to the living beings.

Case Study-4

Ramanjaneya a beneficiary of Gopanahally project has 2 acres of dry land. He was not interested in agriculture because of erratic rainfall and high cost of cultivation. He came to a conclusion that agriculture is not profitable. He attended exposure program under NABARD project organized by GRAMA to Kannamangala in Kolar district. He was impressed by the horticulture crops grown in dry land with minimum use of water and resources. He decided to implement the same technology in his land which was used by the people of Kannamangala. He got 20 sapota and 20 mango seedlings under NABARD program. Apart from this he also treated his land under the same project envisaged above. He took extra care to grow the seedlings. He supplied water from external source for watering of the seedlings. Ramanjaneya on drip irrigation model has put 2 liters of water bottles in each plant for maintaining the moisture. His interest and hard work did not go invain. Inspite of 5% casualties all the seedlings grown and Ramanjaneya will reap the crop in 2-3 years. Now Ramanjaneya has become role model to the villagers.

CAPACITY BUILDING ENTREPRENEURSHIP DEVELOPMENT

The approach towards income generation activities is to encourage vulnerable people with a special emphasis on women with the optimum utilization of locally available resources is continued. The aim is to make the underprivileged to become self reliant. GRAMA's past experience in income generation activities and its strong belief that empowerment of vulnerable people especially women could be achieved through educational awareness and income generation activities. This includes identification of beneficiaries training (including skill) mobilization of raw material resources funds market etc. GRAMA continued its role as mentor to facilitate the loans or any other such support which is needed to promote a sustainable and viable project which benefits the poor. GRAMA facilitated training of over 918 ASHA workers and organized trainings exposure visits EAP/EAP trainings in watershed development and tank development projects.

About 416 beneficiaries are given skilled training in different activities under Sujala-2 (RIDF) watershed project with an investment of Rs. 7356300. Under ASHA programme about 4768 members were trained in pregnancy and child care program with an expenditure of about Rs.2534365.
